#### b) The Budget

The Community Council raises its budget via the local government precept. The precept for 2023/24 equated to £10246 equating to £28.96 per annum per household.

#### **Budget Monitoring**

The Clerk and Responsible Financial Officer presents expenses/budget update reports to the council on a quarterly basis.

The Community Council is committed to using local contractors and suppliers wherever possible and believes in the value of the "Powys Pound."

#### **Council Financial Reserves**

The Council holds financial reserves some of which are held within individual budget headings and others are held within general reserves. It is crucial the Council holds sufficient reserves to maintain its operations effectively and in preparation for future projects and services. A full list of financial reserves is provided to members at the end of each financial year (1<sup>st</sup> April.) These are also reported via the external audit process.

#### **Projects**

During 2023/24 the Council worked on the following projects:

- Following the collapse of Broadway Partners the Council continued to liaise with Powys County Council with regard to Community High Speed Broadband.
- The Council continued with its plan for a new Community Hall and held several engagement events and took on the services of an Funder Finder.
- The Council continues to campaign for the Radnorshire Steam Roller and Living Van to be returned from Kington Quarry to the residents of Radnorshire under the ownership of Powys County Council.
- The Council facilitated funds for King Charles III's Coronation party within the village.

#### **Next Steps**

The Community Council will now continue to work for the benefit of the community and work in developing a new build hall for use as a Community Hub.

The Council also invites ideas from local residents on projects to be developed within the community.

The Council will also continue to work on the Community Broadband scheme in liaison with Powys County Council.
