NC 107/25 Other Matters

a) Gaufron Street Light

Further to our conversation, our electrician inspected the solar light on Tuesday and could not find any fault with it.

I have contacted someone who previously worked for the supplier to see if the issue might be related to the monitoring system, as the company used to be able to dial into the light to monitor it. My suspicion is that the 4G contract may have lapsed now that the solar-light company has gone into liquidation.

I am hoping he replies before next week, but this is looking less likely.

In the medium term we will replace the solar lantern, but this will not be done before next Tuesday, unfortunately.

We did carry out due diligence on this company, as we are always aware that solar companies tend to come in and out of existence. In this case it was a well-established 30-year-old firm, so their collapse was not something we could reasonably have foreseen.

Cllr Bates had approached Cty Cllr Johnson-Wood to see if temporary lighting could be put in place for next week's Carol Service. She awaits her response.

b) Flooding - Llwyn Lane

Cllr Curry brought up the recent flooding along Llwyn Lane running onto the A44. Thi swill be reported to Cty Cllr Johnson-Wood.

c) 2026 Meeting Schedule
